Basic Terms

By using the Omprakash.org website, (the "Website") you agree to be bound by these Terms of Use (this "Agreement"), whether or not you register as a member of Omprakash ("Member"). If you wish to make use of any of the information and resources provided by the Omprakash service (the "Service"), please read and agree to these Terms of Use. If you object to anything in this Agreement or the Omprakash Privacy Policy, do not use the Website or the Service. The Terms of Use are subject to change by Omprakash at any time, effective upon posting on the Omprakash.org website, and your use of the Service after such posting will constitute acceptance by you of such changes.

These Terms of Use apply to all individuals who use the Website at any time for any purpose, including when acting on behalf of any organization or institution (e.g. an Omprakash Partner or any other partnering organization). However, Omprakash reserves the right in its sole and absolute discretion to not provide any earmarked funds to a Designee for any reason, including, without limitation, concerns about the transparency of the Designee's reporting procedures.
- 4. If you would like to donate to defray the costs of travel and living expenses for Omprakash volunteers, you can donate via an Omprakash Crowdfunding campaign associated with specific volunteers. Only volunteers who are participating in the Omprakash EdGE program are eligible to create

Deposit:

By consenting to this waiver, I agree that any fees, deposits, or other monies provided by me to Omprakash are non-refundable, and that any refunds (if any) are at the sole and absolute discretion of Omprakash.

Terms of Use and Privacy Policy:

By consenting to this waiver, I acknowledge that, as a registered user of the Omprakash website (www.omprakash.org), I have read and agreed to the Omprakash Terms of Use and Privacy Policy. I am aware that these Agreements are available for my review at any time. For as long as I

participate in the Omprakash EdGE program or interact with any aspect of the Omprakash.org website, I agree to the Omprakash Terms of Use and Privacy Policy.

Responsibility for Preparation:

For online learning and interaction: Insofar as my engagement with the Program may involve online interaction with other individuals or organizations, either instead of or in addition to any in-person interaction, I assume responsibility for appropriate preparation for this experience.

TO THE FULLEST EXTENT PERMITTED BY LAW, I RELEASE OMPRAKASH, ITS STAFF, VOLUNTEERS AND AGENTS FROM ANY AND ALL LIABILITY ARISING OUT OF ANY LIABILITY, CLAIM, CAUSE OF ACTION, SUIT, LOSS, DAMAGE, INJURY, FINE, JUDGMENT, SETTLEMENT AND/OR EXPENSE (INCLUDING REASONABLE ATTORNEYS' FEES AND COURT COSTS) WHICH MAY BE SUFFERED, MADE, OR INCURRED BY MY NEXT OF KIN AS A RESULT OF MY PARTICIPATION IN THE PROGRAM, INCLUDING, BUT NOT LIMITED TO, ACCIDENTS, ACTS OF GOD, WAR, CIVIL UNREST, SICKNESS, TRANSPORTATION, SCHEDULING, GOVERNMENT RESTRICTIONS OR REGULATIONS, AND ANY AND ALL EXPENSES WHICH I MAY INCUR WHILE PARTICIPATING IN MY TRAVEL OR VOLUNTEER OR ONLINE LEARNING ACTIVITIES.

Indemnification:

I indemnify, hold harmless, and defend Omprakash, its staff, volunteers and agents from and against any and all liabilities, claims, causes of action, suits, losses, damages, injuries, fines, judgments, settlements and expenses (including reasonable attorneys' fees and court costs) which may be suffered, made, or incurred by Omprakash, its staff, volunteers and/or agents as a result of my participation in the Program.

Insurance:

I agree and understand that I am responsible for obtaining, maintaining,

understanding, and paying for my own insurance for the duration of my participation in the Program. Except as otherwise agreed upon by Omprakash, Omprakash does not carry or maintain health, medical, disability or Workers Compensation insurance coverage for myself or any volunteer.

I agree and understand that Omprakash may enter into a relationship with one or more third party insurers in order to provide basic protection for myself and others enrolled in the Program. I agree that Omprakash may subtract any charges or fees for such insurance from my Program fee. I further agree and understand that if Omprakash does enter into a relationship with a third party insurer for my benefit, any and all aspects of insurance coverage are exclusively between myself and the third party insurer.

I understand that, with regard to insurance, my responsibilities are as follows:

- (1) To obtain and understand any and all information regarding my coverage under the third party insurer.
- (2) To decide whether the coverage is sufficient for my needs and/or the purposes of my participation in the Program.
- (3) To obtain additional or supplemental insurance if I so desire.
- (4) To possess and maintain any relevant documents, contracts, identification cards, and contact information regarding my insurance coverage.
- (5) To direct any and all disputes, questions, problems, or general correspondence regarding coverage solely to the third party insurer, and not to Omprakash.

I EXPRESSLY WAIVE OMPRAKASH AND THE PROGRAM FROM ANY CLAIMS OF COVERAGE AND UNDERSTAND THAT MY CONTRACTUAL RELATIONSHIP WITH ANY THIRD PARTY INSURER CONTRACTED WITH FOR MY BENEFIT IS INDEPENDENT FROM AND TO MY RELATIONSHIP WITH OMPRAKASH AND THE PROGRAM. I EXPRESSLY WAIVE OMPRAKASH AND THE PROGRAM FROM ANY SUBROGATION PROCEEDINGS OR DISPUTES OF COVERAGE, EITHER PRIOR TO, DURING, OR FOLLOWING MY PROGRAM PERIOD.

Medical Treatment:

I hereby release and forever discharge Omprakash and the Program from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the my activities with Omprakash or the Program.

Health:

I agree and verify that there are no physical or mental health-related conditions or problems that preclude me from participating. I acknowledge that certain immunizations are recommended, and that I am responsible for obtaining all necessary immunizations.

Background Check:

I agree that Omprakash may perform a criminal history check prior to my participation in the program. I agree to provide Omprakash with my date of birth and other reasonable information (that is permitted by law) that may be requested from time to time by Omprakash.

Acknowledgement:

I acknowledge that I have been advised by Omprakash of the risks and dangers of my participation in the program as well as the need to act in a responsible manner at all times. I agree that Omprakash will not supervise my day-to-day activities, living arrangements, online learning experiences, or fund-raising activities throughout the duration of the Program.

Personal Conduct:

I accept responsibility for the effect my conduct has on the other participants, hosts, Omprakash Partners, and me, and I agree to conform to standards of conduct consistent with maintaining the reputation of Omprakash. I understand and agree that as a participant in the Program, Omprakash policy and corresponding University policies (if appropriate) apply to my activities and participation in the experience.

I understand that I am also responsible for complying with these terms of participation and with emergency procedures adopted by the Program, any relevant University policy, any third party insurance policies and for obeying host country laws while not necessarily enjoying the same privileges as the host country nationals.

I understand that conduct considered unacceptable to Omprakash and the Program includes excessive use of alcohol, fighting, abusive behaviors toward others, sexual harassment, criminal conduct of any kind, participation in (vs. observation of) political activities, use of illegal drugs, or unwillingness to cooperate with host representatives.

I understand that Omprakash and/or its Partner organizations reserve the right to dismiss me from the program if my personal conduct violates these Terms.

Governing Law and Venue:

The laws of the State of Washington (without giving effect to its conflict of laws principles) govern all matters arising out of or relating to this waiver, including, without limitation, its interpretation, construction, performance, and enforcement.

Any claims or actions regarding or arising out of this waiver must be brought exclusively in a court of competent jurisdiction sitting in Seattle, Washington, and I submit to the jurisdiction of such courts for the purposes of all legal actions and proceedings arising out of or relating to this waiver. I waive, to the fullest extent permitted by law, any objection that I may now or later have to (i) the venue of any legal action or proceeding arising out of or relating to this waiver brought in any state or federal court sitting in Seattle, Washington; and (ii) any claim that any action or proceeding brought in any such court has been brought in an inconvenient forum. I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Washington and that this Release shall be governed by and interpreted in accordance with the laws of the State of Washington.

Terms of Use and Privacy Policy:

I understand and agree to all Terms of Use of Omprakash, including all terms, disclaimers, and proprietary agreements. I also understand and agree to the Omprakash Privacy Policy. posted on Omprakash.org by any registered or non-registered users are subject to the proprietary rights of Omprakash and its Terms of Use and Privacy Policy.

General:

This waiver shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns. Except as expressly provided herein, the rights, obligations and remedies created by this waiver are cumulative and in addition to any other rights, obligations, or remedies otherwise available at law or in equity, and nothing herein shall be considered an election of remedies.

My relationship with Omprakash is that of an independent contractor and nothing in this waiver shall be deemed to create an employer/employee, principal/agent, partnership or joint venture relationship. No amendment, modification, replacement, termination or cancellation of any provision of this waiver shall be valid, unless the same shall be in writing and signed by Omprakash. No waiver by Omprakash of any default, misrepresentation, or breach of warranty or covenant hereunder, whether intentional or not, may be deemed to extend to any prior or subsequent default, misrepresentation, or breach of warranty or covenant hereunder or affect in any way any rights arising because of any prior or subsequent such occurrence. No waiver or failure to exercise any option, right or privilege under the terms of this waiver on any occasion or occasions shall be construed to be a waiver of the same or any other option, right or privilege on any other occasion. The provisions of this waiver shall be deemed severable and the invalidity or unenforceability of any provision shall not affect the validity or enforceability of the other provisions hereof. The name assigned to this waiver and the section captions used herein are for convenience of reference only and shall not be construed to affect the meaning, construction or effect hereof.

Consent:

My consent to this waiver is given freely in order to indicate my understanding of the acceptance of the realities of the Omprakash Program and in consideration for being permitted by Omprakash to participate in any and all activities that fall within the scope and duration of my participation in

the Program. My choice to participate in this program signifies my consent to this waiver and shall be deemed to be of the same legal force and effect as an original copy of this waiver bearing my signature as originally written by me.
